Haldane Dodd Executive Director, Air Transport Action Group

Haldane Dodd is Executive Director at the Geneva-based Air Transport Action Group (ATAG). This organisation, the only global grouping of players from across the aviation industry, brings together airports, airlines, air navigation service providers, aircraft and engine manufacturers and SAF producers to agree common goals.

ATAG's current mission is to provide a platform through which the aviation sector is working to reduce its climate change impact. ATAG works with principal partner members ACI, IATA, CANSO, Airbus, ATR, Boeing, CFM, GE Aerospace, Pratt & Whitney, Rolls-Royce and Safran to ensure aviation is able to respond to global decarbonisation and sustainability objectives.

Previously, Haldane was Head of Communications and Advocacy at ATAG and Communications Manager with Airports Council International World headquarters where he worked on issues such as the environment, security and airport economics.

Annie Petsonk

Assistant Secretary for Aviation and International Affairs, United States Department of Transportation

Annie Petsonk serves as the Assistant Secretary for Aviation and International Affairs. A recognized expert on international aviation and climate change, she has previously served in the U.S. government, including the Office of the United States Trade Representative in the Executive Office of the President, and the Department of Justice; in the United Nations; as international counsel for the Environmental Defense Fund, and in the private bar; and as an adjunct professor at the George Washington University Law School.

HH Sheikha Mozah Bint Marwan Al Maktoum

Chairperson, Shehana, Women in Aviation Association

The youngest in her class at the Oxford Aviation, Sheikha Mozah Al Maktoum was only 17 when she was admitted. She obtained her commercial pilot license first and then later joined the Dubai Police Airwing as First Lieutenant Pilot, recently being promoted to Captain Pilot. Her ambitions are only matched by her determination to create a legacy of her own, opening doors and enabling other women to enter a career in aviation. With this mission in mind, she set in motion the establishment of "Shehana", the Women in Aviation Association, with the sole purpose to create opportunities and a framework for increasing the number of women joining the aviation sector.

State Lead Negotiator for Aviation Climate Change and State COP member since 2010. Environment Manager at the General Civil Aviation Authority (GCAA) of United Arab Emirates since 2010.
